



Manual of using the taxpayer personal account for non-residents (e-VAT)

1. Registration in the personal account of non-resident taxpayer.


Step 1. In order to register in the Tax Committee, you should enter the website of the Tax Committee under the Government of the Republic of Tajikistan andoz.tj. When scrolling down, a window of electronic services is displayed, where the “e-Filing system for foreigners” is available.



Step 2. For starting the registration you need to login here.




Step 3. Next, when you open the window, you need to select the option “New Registration”.








2. Login to the personal account of a foreign taxpayer.

Step 1. After a foreign person registers on the website of the Tax Committee, the data for entering his personal account (permanent login and password) is sent to his mail.



Step 2. For entering personal account, you should enter the “e-Filing system for foreigners”.



Step 3. Enter the data that was sent to the mail, and captcha. Then press the “Login” button.






8. To calculate taxes, select the “Calculate” option, to save and send the VAT declaration – “Save”.
